Terms and Conditions for Supply of standard make 98-inch commercial Digital display Unit (Home theatre) with sound system support for 40–50-person capacity auditorium, and standard make 86-inch Interactive panel with accessories for walk-in visitors to be used in Bettiah Forest Division, Bettiah

1. Separate technical and Financial Bids from Registered Indian Suppliers {Manufacturers (OEMs)/ Authorized Distributors/ Dealers/ Suppliers} for the supply of standard make 98" Commercial Digital Signage Board And 86" Interactive Panel with 3 years onsite support to be used in Udaipur Eco-Tourism, Bettiah Forest Division, Bettiah as per the specified item wise requirements, Bettiah can be submitted in the office of Divisional forest Officer, Bettiah forest division , Bettiah, Sanyukth van bhawan, Piunibagh, West Champaran, Bettiah up to 30.10.2024 till 5:00 PM.
2. The manufacturer must ensure supply of “98-inch” commercial Display / Home Theatre and 86" Interactive panel before 30th November 2024 or after this period (Subject to actual requirement on site) as per requirement with onsite installation.
3. Tender Documents along with detailed descriptions of the item and Terms and Conditions of the Tender can be purchased from Office of Divisional Forest Officer, Bettiah Forest Division, Bettiah on Payment of cost of Tender Document/Tender Fee of Rs. 1000/- (One Thousand Rupees only). The original copy of money receipt must be annexed with technical bid. The bid without money receipt for tender fees will be declared technically disqualified and will not be considered at any stage of tender.
4. In case the tender documents downloaded from the website, the cost of tender document/ Tender fees will be submitted by the bidder along with the technical bid in the form of a Demand Draft/ money Receipt of Rs. 1000/- (One Thousand Rupees only) drawn in favor of Divisional Forest Officer, Bettiah Forest Division, Bettiah Payable at any Scheduled Bank at Bettiah or by money receipt. The bid without DD (Demand Draft) or money receipt for tender fees will be declared technically disqualified and will not be considered. The DD (Demand Draft) should be submitted in original. Submission of Photocopy of DD (Demand Draft) as tender fees will not be accepted, and the bid will be declared technically disqualified and will not be considered.

5. The cost of tender document/Tender Fee is non-refundable.
6. The technical bid and the financial bid should be sealed by the bidder in separate envelopes duly superscribed and both these sealed envelopes are to be put in a bigger envelop which should also be sealed and duly superscribed. The bidder must mention Tender details, Name, and address of bidder on the envelope.
7. The received bids (Technical as well as financial) will be open separately. Firstly, the technical bid will be opened before tender committee on 04.11.2024 at 12.00 PMin the office of Divisional Forest Officer, Bettiah Forest Division, Bettiah and after qualifying the technical bid the successful bidder will be eligible for financial bid procedure and subsequently the financial bid will be open Bettiah before Tender committee in the presence of bidders or authorized representatives of bidders. In case any bidder/authorized representative of the bidder remain absent at the time of opening of technical/financial bid, the bid will be considered valid for evaluation.
8. Bids along with necessary documents must be submitted in the Divisional Forest Officer, Bettiah Forest Division, Bettiah before the date and time specified in the NIT. The department/Tendering Authority doesn't take any responsibility for the delay / Non-Submission of Tender for any reason. Late bids (i.e., Bids received after the specified date and time for receipt of bids in NIT) will not be accepted.
9. The technical bids will be opened before the Tender committee at the first instance for evaluation. Financial bids of only the technically acceptable offers will be opened for further evaluation and ranking.
10. Tender will be valid for the financial year 2024-25.

Technical Bid

11. The bidders shall submit their eligibility and qualification details, Certificates in support of their eligibility criteria / technical bids and other certificate /documents as mentioned in tender documents, only in the formats given in the tender document.
12. The bidder shall sign on all the pages of tender documents, supporting statements, documents, certificates submitted by him, owning responsibility for their correctness/authenticity. The self-attested copy of terms and conditions along with NIT need to be attached along with technical bid else the bid will be declared disqualified.
13. The bidder must attach original money receipt/Demand Draft of Rs. 1000/- in technical bids as proof of tender fees.
14. Earnest Money Deposit (EMD) of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand Only) will be in the form of a Demand Draft drawn from a Scheduled

Bank in favor of Divisional Forest Officer, Bettiah Forest Division, Bettiah and Payable at Any Scheduled Bank in West Champaran, Bettiah. The Demand Draft of Earnest Money Deposit need to be attached along with the Technical Bid. In the absence of EMD, the technical bid will be declared disqualified.

15. The bidder must attach a self-attested photocopy of address and identity proof.
16. The bidders shall submit necessary document regarding Ownership/Authorized Dealership/Power of Attorney/incorporation if it is a private limited firm.
17. The bidder must attach a copy of partnership deed in case of firm along with letter of authorization to represent the firm.
18. The bidder must be registered to Income Tax Department. A self-attested copy of the PAN Card and copy of IT return / GST return filed for the last two assessment years (Assessment Year 2022-23, 2023-24 and 2024-25 if filed till the date of submission of bid) must be attached with the technical bid.
19. The bidder must be GST registered. A self-attested copy of the GST Registration and copy of GST quarterly return filed for the last two quarters must be attached with the technical bid.
20. The bidder must have annual turn-over above Rs. 75,00,000/- (Seventy-Five Lakh Rupees only) for last two years. The bidder must enclose along with technical bid, the documents issued by certified chartered accountant, showing annual turnover of last two years (2022-23, 2023-24 and 2024-25 if available)and also must enclose audited balance sheet for the aboveperiod.
21. The bidder must attach documents/certificates regarding the quality standard certificate like ISO/ISI or any other equivalent certification to prove the standardization of the 98-inchcommercial Display / Home Theatre and 86" Interactive panel to be supplied. In the absence of documents regarding standardization, the bid will be declared technically disqualified.
22. The bidder must enclose with the technical bid the brochures/ Catalogues of the materials to be supplied and containing photographs and technical specifications or self-attested color photographs of the 98-inch commercial Display/ Home theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel along with the specifications of the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk in visitors that will be supplied by the bidder. In the absence of these documents, the bid will be declared technically disqualified. Bids of only those bids will be considered for which photograph and technical specification is submitted in technical bid. Only such bids satisfying the specifications provided will be evaluated in the financial bids.
23. In case the bidder is a dealer or supplier, the bidder must submit self-attested photocopy of the authorization certificate issued by the manufacturer of the 98-

inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel, for which technical bid is submitted by the bidder. In the absence of such authorization certificate/letter, the bid for that 98-inchcommercial Display / Home Theatre and 86" Interactive panel t will not be considered. Only such bids for which authorization certificate is provided will be evaluated in the financial bids.

24. The bidder must provide the contact details of the service center/service provider/dealer of the OEM at Patna, who will be providing service to the article /Panel supplied and who will attend the service call within 48 hours of communication for the required service.
25. The bidder must provide 3 Years warranty certificate along with the bid and provide maintenance of 98-inchcommercial Display / Home Theatre and 86" Interactivepanel till one year from date of supply. The bidder must have three year of experience of supplying similar article in Government agencies / Public Sectors
26. It will be the responsibility of the bidder to provide Registrations/ Permissions/ Authorizations/ NOC etc. issued by the concerned Government Department/institution/Board or any other body authorized for such purpose for the operation of the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel to be supplied.
27. Any issue regarding 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel will be resolved by the Supplier. Committee may alter/correct the requirements of the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel if it is felt necessary to do so. The decision of the committee regarding the finalization of requirements of Panelcart will be final and binding on the bidders.
28. In no case successful bidder can change or request to change, the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel or the specification which has been submitted in the technical bid for unavailability or any other reason.
29. Committee will have all the right to disqualify the bid if any malpractices or tempering is found in the submitted bid document.
30. The bidder must supply the materials within 15 days of issuing of the purchase order by Divisional Forest Officer, Bettiah Forest Division, Bettiah. If the supply of commercial Display / Home Theatre and interactive panel requires more than 15 days due to any acceptable reason, the reason and the time required for the delivery must be mentioned along with the technical bid. The committee can

reject the bid technically, if it is found that undue time for supply is quoted by the bidder.

Financial Bid

31. The bidder must mention the cost of 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk -in visitors in digits and well as in words clearly without any overwriting.
32. The cost of 98-inchcommercial Display / Home Theatre and 86" Interactive panel and other items submitted by the bidder will be inclusive of all taxes, cess, fees, fees required for registration/Authorization/NOC etc. of the 98-inchcommercial Display / Home Theatre and 86" Interactive panel, transportation cost till Udaipur Eco-Tourism Center, Bettiah Forest Division, Bettiah loading, unloading and installation etc. No extra/hidden charges will be payable from Udaipur Eco-Tourism Center, Bettiah Forest Division, Bettiah side apart from the cost submitted by the bidder in the financial bids.
33. The cost of 98-inchcommercial Display / Home Theatre and 86" Interactive panel will include AMC charges applicable during warranty period of that 98-inchcommercial Display / Home Theatre and 86" Interactive panel. No separate charges will be paid for annual routine maintenance during warranty period.
34. The cost of material submitted by the bidder must include any other charges or changes in the tax rates etc. as communicated by the central or state government from time to time.
35. Evaluation of the financial bid will be based on the minimum of submitted cost for the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk-in visitors by technically approved bidders.

Supply, Delivery and Maintenance of 98-inchcommercial Display / Home Theatre and 86" Interactive panel -

36. The purchase order for the procurement of the 98-inchcommercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk-in Visitors and other items will be issued after getting approval for the technical and financial evaluation from competent authority.
37. The delivery of the items must be done only to the authorized officer as communicated by the Divisional Forest Officer, Bettiah Forest Division, Bettiah.

38. Successful bidder must supply items within 15 days of issuing of the purchase order by Divisional Forest Officer, Bettiah Forest Division, Bettiah.
39. At the time of delivery, the successful bidder will arrange for the demonstration of the 98-inch commercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk-in Visitors in front of the technical committee constituted by Divisional Forest Officer, Bettiah Forest Division, Bettiah.
40. The payment against supply of will be done by the authorized officer only after delivery by the bidder.
41. The successful bidder must replace/ repair of the technical malfunctioning and must provide the resources for the Maintenance as per schedule, within 48 Hrs. of communication from the office of Divisional Forest Officer, Bettiah Forest Division, Bettiah or Forest Range office, Bettiah under which jurisdiction of Udaipur ecotourism Centre falls. In case the successful bidder fails to provide repairing services within stipulated time, Divisional Forest Officer, Bettiah Forest Division, Bettiah will have all the rights to blacklist the bidder and to forfeit the security money deposited by the bidder.
42. Bidders must abide to all the necessary directions/guidelines communicated by the center/state government from time to time regarding supply and payment of the items. The Divisional Forest Officer, Bettiah Forest Division, Bettiah will have all the rights to cancel purchase of any or all of the 98-inch commercial Display / Home Theatre and 86" Interactive panel without communicating any reason to the successful bidder.
43. The successful bidder will submit a non-judicial stamp paper of Rs. 1000/- (One Thousand Rupees only) for the agreement within a week of issuing of order in this regard.
44. The successful bidder will have to deposit security money equal to 10% of the total cost of the 98-inch commercial Display / Home Theatre with sound system support for 40–50-person capacity auditorium and 86" Interactive panel for walk-in Visitors and other items in the form of Fixed Deposit/Bank Guarantee of any nationalized bank pledged in the name of Divisional Forest Officer, Bettiah Forest Division, Bettiah, with maturity period of minimum 3 years or maximum warranty period of material supplied, whichever is maximum. The security deposit will be returned to the successful bidder after one (1) years or expiry of warranty period of all the machineries that are supplied by the successful bidder, whichever is later.
45. The EMD of unsuccessful bidder will be return within (2) weeks of the date of finalization of tender.

46. If it is brought to the notice of the committee the 98-inch commercial Display / Home Theatre with sound system and 86" Interactive panel for walk-in Visitors of same specification is available in the market at the cost less than that submitted by the successful bidder, the bidder must provide at this lower market rate.
47. If L1 bidder fails to supply the material within stipulated time or do not abide any of the terms and conditions of the tender, the supply of the material can be ordered from other bidders at L1 rate.
48. If the successful bidder does not conform to the terms and conditions of the tender or do not supply the Panel within stipulated time, Divisional Forest Officer, Bettiah Forest Division, Bettiah will have all the right to cancel the contract and forfeit the security deposit as well as to blacklist the bidder from participating in any tender or supply of materials to any government agency.
49. If the successful bidder supplies any lower quality, frequently malfunctioning, then it will be the responsibility of the bidder to remove from the site of delivery with his own expenses within a week of communicating the same. If the bidder fails to remove such item of lower quality from the site, Divisional Forest Officer, Bettiah Forest Division, Bettiah or any officer authorized by him may do so. The cost of removal of Panel from the site of delivery will be recovered from the bidder from his security deposit/EMD. The department will not be responsible for any damages to the materials during this process.
50. Any dispute regarding quality or quantity of the material will be decided by the technical committee appointed by Divisional Forest Officer, Bettiah Forest Division, Bettiah. If bidder is not satisfied with the decision of the committee, then the final decision will be taken by the Divisional Forest Officer, Bettiah Forest Division, Bettiah, West Champaran which will be binding on the bidder.
51. Supply of materials will be done by the successful bidder only.
52. The bidder must certify in the bid that they have read and agree with all the terms and conditions of the tender, and he/she accepts the terms and conditions of the tender.
53. The Divisional Forest Officer, Bettiah Forest Division, Bettiah will have all the rights to cancel part or complete tender without mentioning any reasons for the same.
54. The legal jurisdiction of any dispute arising regarding this tender will lay within the jurisdiction of competent court in West Champaran, Bettiah.
